#### AGENDA ITEMS:

The board approved a variance in regards to the James and Mary Santangelo property.

Two bids were opened for rock. The winning (lowest) bid was awarded to Heuerman Bros. Trucking, LLC.

Brian Larson discussed changes/updates needed on his current lease for the marina. These changes coincide with the approval

of a replat discussed at July's meeting. Attorney Siemer will review the plat information and legal descriptions.

Brian Larson also addressed the board with a proposal of converting four lots in Northwood Hills into three lots. These lots would be much more appealing to potential builders and allow for a more standard floor plan as well. The board was in agreeance with the proposal. Mr. Larson will obtain a plat and discuss the outcome at a future meeting.

Committee reports were presented to the board.

Parks and Rec Committee is moving along with plans for the beach. A general report was provided to the board from Tom Ryan, courtesy of Farnsworth and Mr. Ryan will keep the board updated on plans, surveys and future meetings both on and off site.

The board heard from the fishing committee. They assisted an eagle scout earn a badge by constructing fish habitats. The committee is also discussing improvements at the kayak launch site.
